- 2. Information/Report of the economy financial status of the Applicant issued by the Central Registry of RNM (not exceeding 30 days).
- 3. License for performing Energy Activity or Decision for entry in the register of foreign traders and suppliers of electricity, unless MPRA is submitted by a consumer.
- 4. Certificate for issued EIC or EICVP by the TSO, if the applicant shall posess EIC or EICVP code.
- 5. Certificate from the Public Revenue Office for paid taxes and other public duties prescribed by law (<u>not</u> exceeding 30 days).
- 6. Certificate on absence of bankruptcy or liquidation proceedings (not exceeding 30 days).
- 7. A copy of the regulated balance responsibility agreement concluded with the TSO or a statement for balance responsibility by another market participant which previously regulated the balance responsibility, i.e., is entered in the BRP register by the TSO.
- 8. Statement of authenticity of the Application and the provided data, signed by the person authorized to represent the Applicant.

¹If the Applicant does not possess an EIC or EIC-VP, submits a Request for EIC or EIC-VP along the Application, and EMO shall ex officio on applicant's behalf conduct the application procedure to the TSO for issuance of an EIC or EIC-VP for the applicant.

²EIC-VP - Identification Code Virtual Producer is filled only by applicants who shall participate in the electricity market as an electricity supplier or electricity producer.

* If EMO determines that MPRA is incomplete, within seven working days from the receipt of MPRA, shall notify the applicant and shall set a deadline of 15 days to complete the necessary documentation that is attached to the Request.
