DATA ENTRY INSTRUCTIONS

The data is entered only in a file downloaded from the server

Until the establishment of the web portal for file submission, the files shall be received and submitted via e-mail.

If the file is sent by e-mail, its name/title should be identical to the file name/title stated in the operation list/worksheet (Sheet) General Data

Data is entered with Microsoft® Excel® version 2010 or higher or through Excel Online

Excel Online is available for free to registered users of the Microsoft® web portal

The file structure and content of most cells are protected and should not be changed

Any change to the file structure and / or content of the protected cells will be considered as an invalid report

In the operation lists/worksheets (Sheets) General data, Manual and Info (if any) no data shall be entered!

The submission date (in the General Data operation list/worksheet) will be entered automatically upon submission of the file

The data is entered in worksheets whose names start with a number

Data is entered only in shaded cells

Data should not be entered in the other (locked) cells

On the right side of the table where the data is entered, there is a legend with a (more) detailed explanation about the data that shall be entered In the first column of the worksheet, above the cell **Errors**, the number of rows containing errors is provided.

Each row which contains errors, the corresponding cell in the first column is colored red, and it lists the names of the columns that contain errors or missing data.

Depending on the structure of the table in which the data is entered, the number of columns with an error may be different (usually greater/higher) than the number of incorrectly entered data

As a rule, the data in the shaded cells is mandatory. But, if all the data in a row needs to be equal to zero, data does not have to be entered in those rows

The data will only be considered as valid if in the column **Errors** there is no cell with error.

Please do not submit a file if there is an error in any of the tables!

The file will be rejected by the system for automatic control of the submitted data
