Regulation on Procedures and Deadlines for Issuance, Modification, Transfer, Renewal and Revocation of Licenses in the Electricity Sector

(containing both ERE versions: ERE Decision no. 109 29.06.2016 (EN version) and changes with the Decision of the ERE Board no.215/2019 (ALB version))

Unofficial/convenience translation and consolidation

Article 4

Licenses

- 1. ERE issues licenses for the following activities:
- a. Electricity generation;
- b. Electricity Transmission System Operation;
- c. Electricity Distribution System Operation;
- d. Electricity supply;
- e. Electricity trading;
- f. Electricity Market Operation;
- g. Closed electricity distribution systems;
- 2. No license is issued for the operation of a direct line in transmission or distribution of:
- a. the self-producers that are not connected with the national grid;
- b. when the connection to the national grid is made for the purpose of maintaining its production unit,
- c. the producers, including the self-producers connected with the national grid, with installed capacity up to 1 MW.
- 3. To the extent permitted by the legislation in force of the Republic of Albania, an application for a license for electricity trading or the supply of electricity shall not be required if a company possess a license issued by a Regulatory Authority of another country Contracting Party of the Energy Community/a Member State of the European Union, or another country with which a bilateral agreement has been signed, for the mutual recognition of licenses between the ERE and the relevant Regulatory Authority, and provided that they submit the license to the ERE translated and notarized as well as the information specified in Article 9 (1) and 9 (2), letter "c", of these rules.

- 4. In case the regulator decides to recognize the exercise of the activity of trading and supply of electricity, the company that will exercise these activities will be considered licensed in accordance with applicable law and is subject to all obligations and rights of licensees licensed by the ERE.
- 5. ERE will respond to the request for license recognition with approval or not within 30 working days.
- 6. Foreign traders and suppliers who will be recognized by the ERE will be registered in a special section of the License Register provided in Article 19 of this regulation.

Article 5

Duration of the License Validity

- 1. Duration of the licenses validity issued by ERE for the activities provided in Article 4 of this Regulation, is set by ERE within the following limits:
- a. Electricity generation, up to 30 years
- b. Electricity Transmission System Operation, up to 30 years
- c. Electricity Distribution System Operation, up to 30 years
- d. Electricity Supply, up to 5 years
- e. Electricity Trading, up to 5 years
- f. Electricity Market Operation, up to 5 years
- g. Closed systems of Electricity Distribution, up to 5 years
- 2. For applications in the electricity generation activity, which are submitted to the ERE later than the effective date of the contract / authorization, the calculation of the licensing period is done for the remaining period. This rule also applies to cases of modification of licenses.

CHAPTER II

APPLICATION PROCEDURES

Article 6

The Right to Apply for a License

The right to apply for a license issued by ERE is entitled to any person with its headquarters in Albania and the object of the activity required for licensing. Any foreign person shall set up a company under the

legislation in force, with the object of the activity required for licensing by ERE for the whole period of license validity.

Article 7

Delegation of the Applicator Rights

- 1. The applicant may appoint a natural or legal person as responsible delegate to apply for a license in conformity with the Albanian legislation in force and with the licensing procedures.
- 2. The responsible delegate shall submit at ERE:
- a. The applicant's power of attorney for his representation.
- b. Certification that the responsible delegate is not involved in a process initiated by the justice authorities (certification issued from the prosecution office and the court).
- 3. The tasks of the responsible delegate are:
- a. To submit the application for license together with the required documentation according to Articles
- 8, 9 and 11,15,16,17 of this Regulation;
- b. To submit additional data and information required by ERE during the review of license application.

Article 8

Submitting the application

- 1. The application consists in the application format and documentation defined in article 9 of this regulation, completed by the applicant.
- 2. The applicant shall make the application payment when submitting the application as defined in Annex A of this regulation.
- 3. The documentation submitted by the applicant must be in Albanian, original or notarized photocopy and an electronic copy on CD, USB or e-mail to the official address of the ERE, while certificates and statements from other bodies must be issued no earlier than 1 month from the moment of submitting the application.
- 4. If the applicant has applied and is in process of getting other necessary permissions defined in the regulation, may present the application at ERE by submitting the information from the respective institution for the stage of the process for obtaining the permissions from the other institutions.
- 5. The technical documentation according to the type of license must be drafted and initialed by an individual or legal entity equipped with a relevant professional license according to the legislation in force (electrical engineering, construction engineering, mechanical engineering, accounting experts, hydro technical engineering, etc.).

Article 9

The form and documentation for application

2. Legal, administrative and ownership documentation

a. Foundation act;

- b. Statute (if drafted as a separate document from the founding act);
- c. Certificate of registration and historical extract from the National Business Center (NBC).
- d. Certificate that the company and its main executives in the case of legal entities are not involved in a criminal process initiated by the justice/judicial authorities (certificate from the prosecution and the court).
- e. The organizational chart and administrative functioning of the company, according to the respective positions and profiles. In the case of application for electricity generation license, the submission of a license for electrical technical managers/director is required.
- f. Concession agreement or any other form of agreement in the applicable cases related to the responsible institutions, in accordance with the relevant legal framework and amendment of these acts.
- g. Documents certifying the ownership of the applicant in the areas where the project will be located (ownership certificate, sales contract, lease contracts, agreements with private or state entities that own the project areas for those activities that use assets real estate, etc).

3. Financial and fiscal documentation

- a. Certificate for payment of Taxes and Duties to the Social Insurance Institution (for newly established companies, certificate that there are no obligations).
- b. Presentation of financial balance sheet of the last three years and / or the time of existence of the company (for partnerships with other companies presentation of the balance sheet of the latter).
- c. Documents proving the ability and / or financial support of the applicant, which clearly states the monetary values for financing and the structure of financing (financing of the applicant, bank loans, donations, others, etc.).
- d. "Certificate of payment of the registration fee for the application and request for recognition in the account of ERE., according to Annex A of this regulation."

4.8 Technical documentation for electricity trading activity

a. Electricity quantity projected to be traded in GWh by years;

- b. Financial capital (expressed in monetary values) provided for performance of this activity;, accompanied by a certificate from a bank or other financial institution recognized by law.
- c. List of previous executed contracts (if any).

Article 16

License renewal

- 1. No later than 2 months before the expiration of the validity period of the issued license, the person may/shall request the renewal of the license by submitting the following documents to ERE:
- a. Application form according to Article 9, point 1;
- b. Legal, administrative and ownership documentation according to Article 9, point 2;
- c. Financial and fiscal documentation according to Article 9, point 3;
- d. Any possible modification or amendment of technical data documentation.
- 2. ERE may require from the company any additional information considered necessary for the process.
- 3. The criteria for taking the decision by the Board of Commissioners are the same as in the licensing case.
- 4. ERE publishes in the print (written) media a notice/notification on the license renewal application according to the same procedures that apply to licensing applications in the energy sector.
- 5. In the case of license renewal the Board may consider the fulfillment of the license conditions in the licensed activity by the applicant.
- 6. The Board shall take the decision to grant or not the license renewal or no later than 20 working days from the beginning of the procedures for reviewing an application, in accordance with this regulation.
- 7. To have made the payment of the application fees and regulation fees of ERE.
